ORDINANCE NO. 372

AN ORDINANCE OF THE TOWNSHIP OF INDIANA, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING SECTION 460.01(a) OF THE CODIFIED ORDINANCES OF THE TOWNSHIP OF INDIANA TO PROHIBIT PARKING ON BOTH SIDES OF HURON COURT, LENAPE COURT, MOHICAN COURT AND SENECA COURT; TO PROHIBIT PARKING OR STOPPING ON CERTAIN SECTIONS OF FOX HUNT ROAD; AND ADDING NEW SECTION 460.01(f) TO PROHIBIT PARKING WITHIN TEN (10) FEET OF MAILBOXES WITHIN THE TOWNSHIP BETWEEN THE HOURS OF 8 A.M. TO 5 P.M., MONDAY THROUGH SATURDAY

WHEREAS, the Township of Indiana (the "Township") has adopted ordinances prohibiting parking on certain streets within the Township, as set forth in the Codified Ordinances of the Township of Indiana, Chapter 460, Section 460.01; and

WHEREAS, the Board of Supervisors of the Township of Indiana, in consultation with the Chief of Police, has determined that certain amendments to its parking regulations are necessary so as to promote the convenient and safe movement of motor vehicles within and through the Township and to adequately protect both the safety and welfare of the citizens and residents of the Township as well as the traveling public.

NOW THEREFORE, the Board of Supervisors of the Township of Indiana hereby ordains as follows:

Section 1. Parking Prohibited in the Following Streets

The following shall be added to Section 460.01(a) of Chapter 460 of the Codified Ordinances of the Township, to be inserted into the chart in the appropriate alphabetical order:

460.01 PROHIBITED AREAS

(a) No person shall park any vehicle on any of the following roadways or portions thereof during the periods stated herein:

<u>Roadway</u>	<u>Side of Roadway</u>	<u>Period of Year</u>
Huron Court	Both	All Times
Lenape Court	Both	All Times

Mohican Court	Both	All Times
Seneca Court	Both	All Times
Fox Hunt Road	North Side, from Saxonburg Blvd. to Old Orchard Trail; South Side, from Saxonburg Blvd. for a distance of 150 feet	All Times

Section 2. Parking Near Mailboxes

The following shall be added as new Section 460.01(f) of the Codified Ordinances of the Township of Indiana:

(f) No person shall park any vehicle within ten (10) feet of a mailbox between 8:00 AM and 5:00 PM, Monday through Saturday, except for Federal holidays. A vehicle stopping momentarily to load or unload passengers or merchandise shall not be in violation of this provision.

Section 3. Signage.

The Township Manager or his designee is hereby authorized and directed to place appropriate signage to effectuate the provisions of this Ordinance.

Section 4. Effective Date

This Ordinance shall become effective immediately upon enactment and shall repeal all prior inconsistent ordinances and resolutions to the extent of such inconsistency.

Section 5. Severability

If a final decision of a court of competent jurisdiction holds any provision of this Ordinance or the application of any provision of this Ordinance to any circumstance to be illegal or unconstitutional, the other provisions of this Ordinance and the application of such provisions to other circumstances shall remain in full force and effect.


